Invitation for Bids for the Construction of Track opening of Ratimate to Bhokrekholra Road Section at chaukune-06, Surkhet Contract Identification No: CRM/NCB/WORKS/06/078-079

1. Chaukune Rural Municipality *has allocated funds or received a loan/credit/grant* from [GoN or Development Partner] towards the cost of **Construction of Track opening of Ratimate to Bhokrekholra Road Section at chaukune-06, Surkhet** and intends to apply part of the funds to cover eligible payments under the Contract **Construction of Track opening of Ratimate to Bhokrekholra Road Section at chaukune-06, Surkhet**. Bidding is open to all eligible as per Section V of bidding document..
2. Chaukune Rural Municipality **Surkhet** invites electronic bids from eligible bidders for the construction of **Construction of Track opening of Ratimate to Bhokrekholra Road Section at chaukune-06, Surkhet** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [**NRS 47962979/-**]
 - Minimum Work experience of similar size and nature: [**Earthwork Excavation for opening of track in all type of soil with Value of Nrs. 25580256/-**]
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of [Chaukune Rural Municipality **Surkhet**] or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (**Nrs. 5000/-**) in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at Chaukune Rural Municipality at **2078/10/05 , 2:00 hours**
7. electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp or before [**12:00 hours**] on [**2078/10/20**]. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2078/10/20 on 1:00 hour**] at the office of [**Chaukune Rural Municipality**]. Bids must be valid for a period of [**120 days**] after bid opening and must be accompanied by a bid



security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **[Nrs. 1083963/-]**, which shall be valid for 30 days beyond the validity period of the bid. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
